And today he announced that he will be hitting the road again for THE STATE I'M IN TOUR in advance of new music coming in 2019. The self-proclaimed "Northern Redneck" has achieved critical and commercial success with his last album *SINNER* earning him the No. 1 spot on the Top 200 Albums, Top Country Albums and Top Digital Albums Charts upon release. The 12-track project was voted to numerous Top Albums and Best Of lists and continues to make an impact two years later.

The Pokagon Band of Potawatomi Indians' sovereignty was reaffirmed under legislation signed into law by President Clinton in September of 1994. The Pokagon Band is dedicated to providing community development initiatives such as housing, education, family services, medical care and cultural preservation for its approximately 5,000 citizens. The Pokagon Band's ten-county service area includes four counties in Southwestern Michigan and six in Northern Indiana. Its main administrative offices are located in Dowagiac, Mich., with a satellite office in South Bend, Ind. In 2007, it opened Four Winds Casino Resort in New Buffalo, Mich., followed by Four Winds Hartford in 2011 and Four Winds Dowagiac in 2013. Four Winds South Bend opened January 16, 2018. It owns and operates a variety of business via Mno-Bmadsen, the tribe's nongaming investment enterprise.
